Subject: Solarization of all the Government buildings of the UT of J&K by Installation of Grid-Tied Rooftop Solar Power Plants of aggregate capacity of 200 MW in RESCO mode and 70 MW in Capex mode at a project cost of Rs 400.00 Crore by Jammu and Kashmir Energy Development Agency (JAKEDA), Science and Technology Department-Accord of Administrative Approval thereof.

Government Order No: 36- JK (ST) of 2024 Dated: 31-07-2024

Sanction is hereby accorded to the solarization of all the Government buildings of the UT of J&K by Installation of Grid-Tied Rooftop Solar Power Plants of aggregate capacity of 200 MW in RESCO mode through Solar Power Developers on tariff based bidding and 70 MW in Capex mode at a project cost of Rs 400.00 Crore by Jammu and Kashmir Energy Development Agency (JAKEDA), Science and Technology Department.

It is further ordered that the Rooftop Solar Power Plants will be connected with the Utility Grid on Net Metering basis. The Smart Meters would be provided by the DISCOMs enabled with bi-directional feature. The Virtual Net Metering (VNM) benefit would be provided by the DISCOMs to the Departments, where the excess energy generated by the Solar Power Plant at a particular site would be adjusted against the other sites of the same Department, within the same DISCOM. The Project shall be completed by December 2025.

The above sanction is subject to the fulfilment of following conditions:

 That the supplies to be received shall be verified and shall be strictly as per the MNRE/ Specifications of the NIT.

 That the rates finalized through e-tendering/GeM shall be strictly adhered to.

- That there is not time or cost overrun involvement in the project and set iii. timeline shall be strictly adhered to. No escalation shall be allowed under any circumstances.
- That the Executing Agency shall be selected as per the MNRE directions IV. after following due procedure/codal formalities.
- Photographic evidence after completion of projects shall also be submitted for record and reference purposes along with geocoordinates.
- An amount of Rs 400 Cr includes the amount to be provided by various Departments of the UT of J&K for execution of rooftop solar plants on government buildings of their respective departments in Capex Mode.
- To ensure that strict compliance of the advise of Finance Department VII. conveyed vide their U.O No. FD-Code/57/2022-02 dated 16.077.2024.
- That the CEO, JAKEDA, shall apprise the Administrative Department on regular basis about the progress of the works, once started by the VIII. Executing Agencies.
